| V.                        | Committee Updates     | Landscape: The annual pruning of the palm trees was completed<br>on May 28 th and 29 th<br>One tree on the west wall was cutdown as it was infested with a<br>bark bug and could not be saved. A fica will replace it this Fall.The<br>summer Vinca were planted in the three planter boxes and at the<br>west wall at the pool. These will last until we put in the winter flowers<br>in October.We also replaced several Bougainville on the arenas side<br>and Caballeros side of the property. They have been in-for about<br>five years but never did well. New plants will be better adapted to<br>heat .   |  |
|                           |                       | The landscape company assisted us when we had broken-water<br>pipes in building two and when we needed to locate and replace<br>sewer Clean out pipes in building one and three<br>We need to put a timeline in place to locate and extend the sewer<br>pipes clean outs in both buildings. Building two clean outs are<br>located above ground while those in buildings One and three are<br>currently buried to about 18 inches below ground. It could costs is<br>\$800 per clean out cap.<br>My recommendation is to do at least four per year until we get<br>all.Located and pipes extended above ground.<br>We have about 10 left in each building.<br>About 8000k per building with us digging the holes. |  |

We ask that lounges<br>not be moved as they are set six feet apart for social distance.<br>We want our residents to enjoy the spa/pool while respecting others<br>rights.<br>We are notifying swimmers when they violate the rules and the<br>board reserves the right to shut down the pool and spa if ordered by<br>city or county and when violations occur. |
