The fall flowering plants have been removed and will be replaced with Vinca for summer blooms. Palm Springs gold is being spread to recover bare spots on walkways and shrub beds. The Landscape company is working to adjust the use of water over the summer months. The goal is to maintain the property without over watering during the heat of Spring and summer as we are in a water shortage period.	
	POOL REPORT	We had several complaints regarding the spa jets a) not turning off and b) not working. Both of these issues have been checked and rechecked and the pool jets are working just fine. Just as a reminder to those parents or grandparents who bring children to our pool they should always be supervised by a
